1	Erection & commissioning of naturally Ventilated Tubular Structure Greenhouses	The structure should be of Zero energy naturally ventilated greenhouse by using GI structure 60 OD main column, 48 OD perlin and arc 2mm thick. The central height should be 5 mtrs complete fitting and fixing using standard cladding material Ginegar/ Essen made 200 micro thick driplock 5 layered, super clear, antidrip UV stabilized poly film followed with 30 mesh insect proof net below the curtain with rolling system of ventilation. The installation should be done in the farmers field and sizes of the structure will be as per the given specification/ suitability of the land available.	100 sqm/ unit)	The locations of the green houses to be erected are all over Sikkim.

Terms and conditions:

- 1. The quotations must be submitted in a sealed envelope. NIQ reference No. must be written very clearly on the envelope. Two rates may be submitted:
 - i. One rate shall apply to for the General Areas.
 - ii. Other rate to be submitted for carrying out the above works in high altitude border areas/ restricted areas.
- 2. Quotations only from the Empanelled manufacturers/ dealers/ suppliers of SIMFED shall be accepted. Empanelment must be valid (Expired empanelment shall not be accepted). Further, the empanelment must be at least one year old.
- 3. ONLY Quotations from those parties who have executed similar work in the state of Sikkim shall be accepted. The minimum work undertaken of similar nature should not be less than 5,000 sqm during the last three years. Proof of similar work under taken earlier is to be enclosed.

- 4. All quotations are to be submitted to the General Manager (I), SIMFED, Development Area, Gangtok, East Sikkim 737101 on the 14.05.2025 between 11 am to 1pm . After the stipulated time no quotations will be accepted.
- 5. The quotations submitted are "For establishment" of rates and does not guarantee issue of any supply order in the event the supply order is not received from the indenting department.
- 6. An amount of Rs. 10,000.00 may be deposited as Tender fees. This amount is non refundable. The amount may be paid in cash (at the accounts section of SIMFED) or by Demand Draft in favour of the Managing Director, SIMFED. Cheques will not be accepted.
- 7. EMD @ 2.5% of the work value should be submitted in cash (at the accounts section of SIMFED) or by Demand Draft in favour of the Managing Director, SIMFED (Cheques will not be accepted) before release of the work order else the work order shall not be awarded.
- 8. The above work is to be completed within 40-45 days after the issue of the supply order.
- 9. The materials should be strictly as per the specifications and quantity mentioned.
- 10. Trade discounts being offered to SIMFED must be mentioned clearly in the quotations.
- 11. Payment on successful supply will be made only after receipt of the payment from the indenting department and on obtaining the completion certificate from the indenting department.
- 12. The vendor submitting the quotations must have cleared the processing fees and other dues with SIMFED Accounts Section.
- 13. Submission of the quotations assumes that the party has accepted all the terms & conditions and will accept the decision of management of SIMFED.
- 14. The rates submitted by the L1 shall be verified and if found abnormally higher than the prevailing rates of the market then the management reserves the right to cancel/renegotiate or any other decisions that may be beneficial for the end buyer.
- 15. Supply/ work order shall be given to the lowest bidder and after acceptance of the rates by SIMFED on the condition that the rates are further accepted by the indenting department and a Supply Order is issued by them in favour of SIMFED.
- 16. The management of SIMFED reserves the right to accept or reject any quotations without assigning any reasons thereof. The Decision of the Managing Director is final & binding on all in all circumstances & situation.
